<u>RATES</u>

Permanent Moorage: Prices are per foot/per month, plus State L/H Tax (12.84%)

20 ft. Slip \$9.19 / lf / month 30 ft. Slip \$9.58 / lf / month 40 ft. Slip \$10.18 / lf / month 50 ft. Slip \$10.99 / lf / month 60 ft. Slip \$11.52 / lf / month 80+ ft. Slip \$12.36 / lf / month

The moorage rate is based on overall length or slip length, whichever is greater.

<u>Transient Moorage:</u> Less than 75' \$1.65 / lf / day

75' or greater \$2.50 / lf / day

Limited Access Slips: \$6.45 / lf / month

Electrical Reconfiguration Rate: \$25.00/each (for amperage change)

Permanent Electrical Rate: 120V 10AMP \$49.28 / month 240V 30AMP \$127.11 / month

120V 15AM \$56.08 / month 240V 40AMP \$140.94 / month 120V 20AMP \$61.10 / month 240V 50AMP \$155.07 / month

120V 30AMP \$66.74 / month 120V 40AMP \$72.51 / month 120V 50AMP \$78.21 / month

Metered Electricity: \$10.00 per month plus usage \$0.09 / KW*

<u>Liveaboard Rate:</u> \$175.00 / mo. (maximum of 2 people)

Wharfage: \$0.01 / lb

Waiting List: \$50.00 Application fee \$25.00 annual fee thereafter

Access Card: \$20.00 for additional card (one is included with permanent moorage agreement)

Shower Facilities: \$.50 / five minutes Laundry Fee \$1.50

Storage Boxes: \$10.00 per month

Launch Ramp Fees:

Daily \$18.00

Annual \$100.00 / year Late Season (Sep 1st – Dec 31st) \$50.00 Commercial Vessel Activity \$300.00 / year plus appropriate launch ramp fees (non-refundable)

\$2.00 per person (daily) for commercial charter operations

Commercial Buyer Operating Fee Weekly: 1 day or more \$300.00 per vehicle

Yearly \$1,500.00 per vehicle

Hoist Facilities with Operator: \$25.00 / lift or \$75.00/hr.

<u>Late Moorage Payment</u> 1% /month on unpaid balance plus an additional \$50.00 /month fee after 61 days
