Description of proposal: Port of Port Angeles, William R. Fairchild International Airport Hangar Development Project. The project includes site preparation and construction of a pre-engineered metal building on Hangar Site E and adjacent taxilane expansion. This work includes grading, paving, pavement markings, subdrains, surface drainage improvements, concrete building foundation, construction of the hangar building, and service connections to the existing water and sewer utilities. This aircraft hangar will be 17,500 square feet, and an adjacent taxilane expansion will be approximately 18,750 SF of asphalt paving. See [link](#) to 60% design drawings

Determination: Port of Port Angeles has determined that this proposal will not have a probable significant adverse impact on the environment. This determination is based on the following findings and conclusions:

- The project will comply with all state, federal and local regulations, best management practices, permits, mitigation requirements and agency requirements to minimize impacts that could occur from the project. The project would begin at William R. Fairchild International Airport, after issuance of all permits and approvals. A list of anticipated permits and approvals is included in the SEPA Checklist.
- The proposed project site is located within the existing airport boundary, between two existing hangars, and is identified as a designated hangar development area in the Airport Layout Plan. The project does not propose any changes to the airport land uses.
